We followed with great interest and satisfaction your statements at the beginning of September 2021, which reflected part of the situation in the Republic of Yemen and reflected the reality of international dealings with it and gave the impression that your assumption of the presidency of the Security Council will deal positively and with a desire to achieve tangible results on the reality in this complicated file, the bleeding wound and the shameful stigma on the forehead of the world and its international organizations towards Yemen and its people.

Yemen is experiencing the worst humanitarian crisis and the most horrific war that has represented an unprecedented massacre and a collective punishment for an entire people whose land has turned into a land of regional and international ambitions by tyrannical forces that do not want them to have a free and dignified life, good economic and development infrastructure available to them through their struggle, and the security and stability they were enjoying. Such forces destroyed all these achievements, and then turned towards the Yemeni human being and killed them with hatred and violence, imposed a blockade on them, and made them starve to death.

At a time when Yemen and Yemenis are living in this situation, the international community and its relevant international organizations, led by the United Nations and the UN Security Council, did not dare to take any measure to relieve Yemen and its people of the suffering they are experiencing as a result of the aggression and siege that have been imposed for seven years.

We have followed the assertive statements issued by you that the United Nations and the Security Council have been exhausted and tired of following the situation in Yemen without reaching a conclusion, and the reason for this is due to the poor mechanism that is adopted in following them up, and also due to their failure to delve into the depth of the crisis, its causes and parties, and the inability to take decisive decisions against the parties that allied themselves with the aggression against Yemen and its people with the aim to destroy all of its human and material resources and capabilities.

The House of Representatives of the Republic of Yemen, the legitimate and constitutional representative of the Yemeni people, appreciates your positive statements regarding the Yemeni file and considers them a source of optimism that suggests the existence of a new vision in the presidency of the UN Security Council, towards resolving the Yemeni file.

We hope that the UN Security Council during your presidency will play its humanitarian and legal role, and that your positive statements will be urgently translated into reality. We also hope that the UN will issue a resolution binding the countries of the coalition of aggression on Yemen to immediately cease the aggression on all Yemeni lands and lift the siege, and to cancel all unfair UN resolutions against Yemen and its people issued by the Security Council that have no justification or legal or humanitarian grounds, which represented an entry point for the countries of the coalition of aggression to implement what they have been plotting for decades of plans and conspiracies aiming at imposing hegemony and tutelage on Yemen, occupying parts of its lands, looting its wealth and destroying its capabilities, killing its children, women and elderly, displacing its children and making the worst humanitarian crisis the world has seen.
